Kick off Meeting for the EU Financed Project "National Rural Parliament as a Voice of Rural Citizens", Financed by EU

NVP Foundation in cooperation with the RDN of RM (Rural Development Network of Republic of Macedonia) and the ARD (Action for Rural Development), on April 10th, in the EU Info Centre, have conducted the kick-off meeting of the project "National Rural Parliament as a voice of rural citizens" - NRP.

Based on previously identified needs and constrains of civil society organisations from rural areas the project was designed to strengthen the civil society influence on local and national policies concerning rural development. This will be achieved through enhancement of rural CSOs capacities for networking and advo-





cacy in order to influence local decision making processes and contribute to strategic partnerships with the local and national Government.

The NRP project is a 30 months project, funded by the European Union and implemented by the above mentioned three partner organisations.

The action will involve minimum 40 grass root CSOs working in rural areas, on average minimum 5 CSO's from 8 planning regions in Macedonia, including also minorities and many ethnic groups. The main working method will be training, coaching and learning by doing. These methods will empower rural CSOs to be actively involved in the decision making processes and increase their voice in the society.

Final beneficiaries from the project are all people living in rural areas.

At the end of the two and a half year period the project expect to reach the following four results:

- Enhanced transfer of know-how among rural CSOs related to rural challenges and decision making
- Built management capacity of rural CSOs to lead rural development processes
- Developed research and analysis skills of rural CSOs
- Facilitated effective dialogue between rural CSOs and local/ national government





Civil Society Organizations Will Work Together to Improve Rural Development Policies

uring May and June, 2017, the "National Rural Parliament as a voice of Rural Citizens - NRP" project, organized 7, out of 8 planned meetings with CSOs in the Southeast, East, Southwest, Northeast, Pelagonija, Vardar and Polog region, in order to encourage them to discuss the possibilities for their greater involvement in creation of policies related to rural development and to identify CSOs that work actively in the field of rural development. Approximately 130 representatives of CSOs attended the meetings organized in: Pehchevo, Strumica, Struga, Tetovo, Bitola, Kumanovo and Negotino. The eighth meeting will be organized on July 13th in Skopje for the CSOs in the Skopje planning region.

The project organized these meetings with CSOs, to present planned activities and to encourage more active participation of the organizations in the process of capacity building for networking and advocacy. In this way, the project aims at strengthening the influence of civil society through its involvement in the development of public policies, civil dialogue and decision making to improve the living conditions in rural areas.









The meetings with the Civil Society Organizations in the 8 planning regions of the Republic of Macedonia will be used as basic input for development of a register of active CSOs working in the area of rural development. Within this activity, the project will conduct field inquiry to identify as much as possible rural

CSO's working on topics related to rural development.

The implementation of the "National Rural Parliament as a Voice of Rural Citizens - NRP", funded by the European Union, started in March 2017, by the three partner organizations: Connecting Natu-





ral Values and People Foundation (CNVP), the Rural Development Network of the Republic of Macedonia (RDN of RM) and Action for Rural Development (ARD). It is anticipated the project activities to include 40 local organizations in rural areas, approximately 5 CSOs in each of the 8 regions in Macedonia, including minorities and different ethnic groups. The main method of work will be training, coaching and practical learning, which will encourage greater participation by the rural CSOs in the decision-making processes and creating strategic partnerships with local and national authorities.





MICRO – Increasing Competitiveness of Microenterprises in Rural Areas



he Community Development institute – Macedonia has been working on implementing the MICRO - Increasing Competitiveness of Microenterprises in Rural Areas Project, as part of its activities for support and development of enterprises in rural areas in the Republic of Macedonia, in cooperation with its partners from Ireland, Spain, Greece and Italy. The project is supported by the Erasmus+ EU Programme.

The MICRO Project encourages de-



velopment of basic and cross-cutting skills such as entrepreneurship, ability to function within the internal EU market and self-employment through an innovative approach. This approach of the MICRO Project relies on its bottom-up approach, motivated by the demand, and consolidating the expertise of interns attending vocational education and training, as well as experts in given areas.

The innovative method also relies on the open approach to using the results, so that MICRO is becoming an open platform not only for training and capacity building, but also for networking, facilitating cross-border exchange and cooperation and identification of partners for rural microenterprises from EU member states.

In the course of implementation, MICRO has been supporting development of high-quality work-oriented solutions in the field of vocational education that could be implemented in existing microenterprises in order to strengthen their competitiveness.

Rural Coalition – Kumanovo Activities in the Civil Sector

► Successful implementation and completion of the project "Market Economy and Institutional Capacities" - this was marked by final presentation of the results achieved within the project, which attracted wide media attention. 5 public debates in 5 planning regions in 5 towns were organized in the country (Kumanovo, Strumica, Gostivar, Struga, and Prilep), where institutions and farmers discussed their relations, capacities, efficiency and effectiveness of the institutions and service provision, as well as the extent both parties influence the establishing the relations of market economy. Additionally, a detailed analysis was carried out of the work of five key institutions in the sector of agriculture and rural development (Ministry of Agriculture, Forestry and Water Management, Agency for Financial Support of Agriculture and Rural Development, National Extension Agency, Food and Veterinary Agency, State Agriculture Inspectorate) in terms of service provision, efficiency, effectiveness, transparency, availability to citizens in correlation with the number of employees in each institution and the annual budget or funds at disposal to each institution for operations; the final result of the project was a published analysis with





recommendations to institutions derived directly from farmers for the purpose of improving their work. This analysis was distributed to the institutions and is available on the following link: http://rural.mk/pro- ekti/realizirani/pazarna-ekonomijai-institucionalni-kapaciteti/ Added value to the project was the designed map of institutions to be used by farmers at any time, so that they can identify competencies of separate institutions in order to avoid going from office to office if they need to exercise their rights or carry out their obligations. The project was financially supported by the Foundation Open Society Macedonia.

► Promotion of the brochure "Laws Exist, Implementation is Lacking – the Law on Agriculture and Rural Development – Grounds for Development of Competitive Farming" containing the analysis of the Law on Agriculture and Rural Development, with an emphasis on legal provisions that affect farmers the most and that draw upon their rights and obligation, all for the purpose of better informing the farmers on what they can base their demands when there is a need for this within their communication with the institutions, or regarding the sections related to regulation of their relations with buyers and final consumers. The brochure was a final product of 8 months activities of the Rural Coalition, implemented as part of the IPA 2 Mechanism for Civil Organizations project implemented by EUROTHINK, Eco-Awareness, Reactor and Zenith, in the process of sub-granting, within the IPA Programme on Civil Organizations and Media 2014. The brochure including developed guidelines on improved implementation of the Law on Agriculture and Rural Development, covering also the field research on the extent of the knowledge of farmers about the law, is available on

► The Rural Coalition successfully completed the process of drafting a strategy for organizational development for the period 2018-2020, including a reviewing of the past vision, mission and method of action of the organization. The process was comprehensive and started in February 2016 by identifying the needs of the organization and the target groups, followed by a thorough process of screening the capacities of the Coalition as a network, the capacities of member organizations of the Coalition, as well as analysis of human and technical resources at disposal to the Coalition and its members. The process was monitored by national and international experts in the area, with full technical and logistical support by the TAKSO office in Macedonia; the process ended in June this year, and covered








two workshops with international experts regarding networks and coalitions, followed by working groups for drafting different sections of the strategy with a national mentor including a three day workshop and three working session of the groups

that directly participated in the drafting of the strategic document. It has been planned for the strategy to be adopted at the Annual Assembly of the Coalition in September-October this year; its implementation is planned to start in 2018.

Education of Individual Agricultural Producers to Use Standardized Seeds and **Seedlings Material**

he Association of Producers of Garden and Flower Varieties HORTI ECO from the Village of Dobrejci, Strumica region, has started with the implementation of the project on Education of individual agricultural producers to use standardized seeds and seedlings material, financially supported by the Municipality of Strumica. In cooperation with the communal enterprise Komunalec - Strumica, several areas in Project engages young people from





tar Vlahov Secondary Municipal School studying horticulture were also involved and had an opportunity to acquire practical experience under supervision of several professors and the communal enterprise Komunalec - Strumica. One of the activities is to raise the awareness of young people on production and use of standard seeds and seedlings.

They had an opportunity to taste different kinds of wine of native grape varieties produced according to old traditional methods, such as the famous Melnik wine of the variety Wide Melnik Vine. The festival invigorated the town with hundreds of domestic and international guests to taste the red elixir and to enjoy the magic of the Melnik sand pyramids. The goal of this festival is to popularize wine as a national product and develop the region as a wine tourism destination, contributing to preserving tradition and improving conditions of rural living.

10th International Fair on Livestock and Poultry – Zootechnia 2017 held in Thessaloniki

On 4 February 2017, Horti Eco Association from Strumica organized a visit for a group of 75 farmers from Macedonia from the Village of Dobrejci, Strumica region, to the 10th International Fair on Livestock and Poultry – Zootechnia 2017 held in Thessaloniki, Greece. At the fair





farmers had an opportunity to get acquainted with new technologies applied in the livestock sector, and also the latest designs of farming machinery, equipment and input material. The goal of the visit was to exchange experience and ideas, to demonstrate practical application of new techniques and technologies in agriculture, to extend and encourage their application in our country, to initiate cooperation and partnerships, as well as to replicate innovative production methods.

The workshop was supported by We Effect as part of the activities implemented by the Rural Development Network of the Republic of Macedonia within the project "Support Balkan Rural Development Network - BRDN as a functional regional platform for cooperation of rural networks". The project's activities focus on capacity building of the Balkan Rural Development Network (BRDN), in order to increase sig-



nificantly the ability of its member organizations, which play a leading role in sustainable socio-economic development, to dialogue with Governments influencing policy, and decision-making processes in the rural areas. Capacity building actions for BRDN relates to internal governance, financial and project

management, long-term planning, funding diversification and networking. Strong focus of the project is put on the support to rural women in the process of capacity building and inclusive networking as a basis for decreasing the negative influence of the disadvantages arising in the rural areas.







38th SWG Assembly Session and Meeting of the Rural Development Networks From South Eastern Europe
